- Divisions:** PreK – K, 1-2, 3-4, 5-6, 7-8. Four- person round robin format. Note: PreK, K, 1st & 2nd grade may choose No- Tears or standard competition. No- Tears Will not be scored and the wrestler will wrestle 3 one minute periods. Wrestlers in No- Tears will receive a medal and charts will not be awarded.
- Cost:** \$10.00 pre- registered, \$15.00 at the door. **No USA Card Required.**
- Admission:** \$2.00, ages 12 and up.
- Match Time:** 3 one-minute periods for PreK-6th grade. One-minute period for the 1st period, and two-minute for 2nd and 3rd periods for 7th and 8th grade. First takedown in overtime wins. WIAA rules will be followed. **NO HEAD THROWS** for PreK through grade 2.
- Registration:** Pre-registration accepted. Walk ins welcome.
- Weigh-Ins:** Weigh ins will be from 7:00 – 9:00 a.m. Sunday, February 8, 2008. Singlets must be worn for weigh in.
- Time:** The school and gym will be open at 7:00 a.m. and wrestling will begin upon completion of charting.
- Team Trophy:** \$10.00 entry fee per ten-member team in the team competition. Pick up forms at the check in table. Trophies for 1st, 2nd, and 3rd places.
